Vote Ratings U.S. House of Representatives 110th Congress, First Session

Representatives were scored on the following votes:

1. AMT Relief Act (12/12/2007, Roll Call No. 1153)

12/12/2007 -- The House passed H.R. 4351, to amend the Internal Revenue Code of 1986 to provide individuals temporary relief from the alternative minimum tax, by a yea-and-nay vote of 226 yeas to 193 nays, Roll No. 1153.

2. Creating Long-Term Energy Alternatives for the Nation Act (12/06/2007, Roll Call No. 1140)

12/06/2007 -- The House agreed to the Senate amendments with amendments, made in order by the rule and printed in H. Rept. 110-474, to H.R. 6, to move the United States toward greater energy independence and security, to increase the production of clean renewable fuels, to protect consumers from price gouging, to increase the energy efficiency of products, buildings, and vehicles, to promote research on and deploy greenhouse gas capture and storage options, and to improve the energy performance of the Federal Government, by a yea-and-nay vote of 235 yeas to 181 nays, Roll No. 1140.

3. Number 2 above was double rated.

4. United States-Peru Trade Promotion Agreement (11/08/2007, Roll Call No. 1060)

11/08/2007 -- The House passed H.R. 3688, to implement the United States-Peru Trade Promotion Agreement, by a yea-and-nay vote of 285 yeas to 132 nays, Roll No. 1060. Consideration of the measure began on Wednesday, November 7th.

5. Childrens Health and Medicare Protection Act of 2007 (08/01/2007, Roll Call No. 786)

08/01/2007 -- Rejected the Granger motion to recommit the bill to the Committees on Energy and Commerce and Ways and Means with instructions to report the same back to the House forthwith with amendments, by a yea-and-nay vote of 202 yeas to 226 nays, Roll No. 786.

6. Farm, Nutrition, and Bioenergy Act (07/27/2007, Roll Call No. 756)

07/27/2007 -- The House passed H.R. 2419, to provide for the continuation of agricultural programs through fiscal year 2012, by a recorded vote of 231 yeas to 191 noes, Roll No.

756. Consideration of the measure began on Thursday, July 26th.

7. Number 6 above was double rated.

8. Eightmile Wild and Scenic River Act (07/11/2007, Roll Call No. 615)

07/11/2007 -- H.R. 986, amended, to amend the Wild and Scenic Rivers Act to designate certain segments of the Eightmile River in the State of Connecticut as components of the National Wild and Scenic Rivers System, by a $\frac{2}{3}$ yea-and-nay vote of 239 yeas to 173 nays, Roll No. 615.

9. Setting forth the congressional budget for the United States Government for fiscal year 2008 and including the appropriate budgetary levels for fiscal years 2007 and 2009 through 2012 (05/17/2007, Roll Call No. 377)

05/17/2007 -- The House agreed to the conference report on S. Con. Res. 21, setting forth the congressional budget for the United States Government for fiscal year 2008 and including the appropriate budgetary levels for fiscal years 2007 and 2009 through 2012, by a yea-and-nay vote of 214 yeas to 209 nays, Roll No. 377.

10. Ryan of Wisconsin Substitute Amendment (03/29/2007, Roll Call No. 211)

03/29/2007 -- Ryan (WI) amendment in the nature of a substitute (No. 3 printed in H. Rept. 110-79) that sought to retain the 2001 and 2003 tax provisions, and provides for one-year extensions of alternative minimum tax [AMT] relief, the State and local sales tax deduction, and the research and experimentation [R&E] tax credit and also sets discretionary spending at \$1,079.6 billion in fiscal year 2008 and \$5,079.8 billion over 5 years (by a recorded vote of 160 ayes to 268 noes, Roll No. 211).

11. The Employee Free Choice Act (03/01/2007, Roll Call No. 117)

03/01/2007 -- Rejected the McKeon motion to recommit the bill to the Committee on Education and Labor with instructions to report the same back to the House forthwith with an amendment, by a recorded vote of 202 ayes to 225 noes with 1 voting "present", Roll No. 117.

12. Creating Long-Term Energy Alternatives for the Nation Act (01/18/2007, Roll Call No. 40)

01/18/2007 -- The House passed H.R. 6, to reduce our Nation's dependency on foreign oil by investing in clean, renewable, and alternative energy resources, promoting new emerging energy technologies, developing greater efficiency, and

creating a Strategic Energy Efficiency and Renewables Reserve to invest in alternative energy, by a yea-and-nay vote of 264 yeas to 163 nays, Roll No. 40.

13. Number 12 above was double rated.

14. Medicare Prescription Drug Price Negotiation Act (01/12/2007, Roll Call No. 22)

01/12/2007 -- Rejected the Barton of Texas motion to recommit the bill to the Committees on Ways and Means and Energy and Commerce with instructions to report the same back to the House forthwith with an amendment, by a Yea-and-Nay vote of 196 yeas to 229 nays, Roll No. 22.

15. Fair Minimum Wage Act (01/10/2007, Roll Call No. 17)

01/10/2007 -- Rejected the second McKeon motion to recommit the bill to the Committee on Education and Labor with instructions to report the same back to the House forthwith with an amendment, by a Recorded vote of 144 ayes to 287 noes, Roll No. 17.

16. Adopting the Rules of the House of Representatives for the One Hundredth Tenth Congress (01/05/2007, Roll Call No. 10)

17. Campbell Sign-on Letter: Congressmen promise in writing to sustain a Presidential veto of a bill on the grounds that it spends too much money.

18. Feeney Sign-on Letter: Congressmen promise in writing to sustain a Presidential veto of a bill on the grounds that it raises taxes.

85% or higher earns the “Hero of the Taxpayer” award. Pledge violators are not eligible to receive the award.
